 - *S.263 – An act relating to expanding Vermont’s health care workforce through graduates of international medical schools.* This bill proposes to require the Board to convene a work group to develop proposals to “harness the expertise of international medical school graduates (IMGs) to increase Vermont’s health care workforce.” The Board will be asked to establish a position on the bill.
 - *S.233 – An act relating to amendments to the scope of practice for optometrists.* Brief update on the bill. The Board has already established a position.
