- **Call to Order; Call the Roll; Acknowledge Guests:**

- **Presentation of Applications:**

- **FSMB Draft Policy Comment:** Dr. Hildebrant stated that he, Dr. Clattenburg, and PA-C Jones met to discuss comments on FSMB's draft policy. D. Herlihy attended and prepared draft comments summarizing the group's discussion, which were shared with the Board prior to the meeting.

L. LeCours made a motion to approve the comments about the FSMB draft policy as presented to the Board. Seconded by Dr. Tortolani. The motion passed; opposed: none; abstained: none; recused: none.

- **Radiology Assistant Bill:** D. Herlihy shared that there was draft language prepared to put in two changes regarding Radiology Assistants (RA), as was proposed to the Board by UVMHC at the February meeting. On behalf of the Board, D. Herlihy had requested two changes to the first draft; UVMHC had agreed with that request and the result was the draft bill shared with the Board on March 14. One addition was to specify that if the radiologist supervising the RA is remote there must be a physician on site at the facility where the RA is providing services to provide backup in the event of a medical emergency. The other addition was language making it clear that "preliminary

observations” shall not include comments about features or characteristics that would be considered in making a diagnosis. The House Health Care Committee has taken the requested language up as a committee bill and they expect to vote on it either the afternoon of March 15 or on March 17. D. Herlihy asked for any members with concerns about the proposed language to raise them at that time. No members voiced concerns. D. Herlihy advised that an email will be sent following the meeting stating that the Board has no objections.
